## **Invitation to Bid for the Repair and Improvement of Regional Finance Service Office, Camp BGen Efigenio C Navarro, Calapan City, Oriental Mindoro**

1. The Philippine National Police PRO MIMAROPA through the PNP Trust Receipts for the month of July 2021 intends to apply the sum of **One Million Four Hundred Fifty Thousand Pesos (Php 1,450,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Repair and Improvement of Regional Finance Service Office, Camp BGen Efigenio C Navarro, Calapan City, Oriental Mindoro** under Public Bidding No. 2021-19. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Philippine National Police PRO MIMAROPA now invites bids for the above Procurement Project. Completion of the Works is required **within 60 calendar days from the receipt of the Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.

4. Prospective Bidders may obtain further information from Philippine National Police PRO MIMAROPA and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested bidders on **November 4, 2021 to November 24, 2021 at 2:00 PM** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The Philippine National Police PRO MIMAROPA will hold a Pre-Bid Conference on **November 12, 2021** at Regional Headquarters Conference Room, Camp BGen Efigenio C Navarro, Calapan City, Oriental Mindoro, and/or through videoconferencing, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address at the PRO MIMAROPA BAC Secretariat, Camp BGen Efigenio C Navarro, Calapan City, Oriental Mindoro on or before **November 24, 2021 at 2:00 PM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **November 24, 2021 at exactly 2:00 PM** at the **Regional Headquarters Conference Room, Camp BGen Efigenio C Navarro, Calapan City, Oriental Mindoro**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Philippine National Police PRO MIMAROPA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
