INVITATION TO BID

The Police Regional Office MIMAROPA, through the funds from PNP STL FUND - NHQ intends to apply the sum of **One Million Three Hundred Fifty Seven Thousand Seven Hundred Forty Pesos (Php1,357,740.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the Procurement of Medical and Dental Equipment. Bids received in excess of the ABC shall be automatically rejected a bid opening.

The Police Regional Office MIMAROPA now invites bids for the Procurement of Medical, Dental and Laboratory Supplies. Delivery of the Goods is required fifteen (15) working days after receipt of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

A complete set of Bidding Documents may be acquired by interested Bidders from the address below starting the first day of advertisement from 8:00 AM to 5:00 PM during working days until the deadline for the submission and opening of bids, pursuant to the latest Guidelines issued by the GPPB.

It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee in the amount of **Five Thousand Pesos (Php5,000.00)** for the Bidding Documents not later than the submission of their bids.

The PRO MIMAROPA Bids and Awards Committee will hold a Pre-Bid Conference on **February 26, 2020 at 2:00 PM** in the Regional Headquarters Conference Room, Camp Efigenio C Navarro, Calapan City, Oriental Mindoro with all interested parties.

Bids must be duly received by the BAC Secretariat at the address below on **March 4, 2020 until 2:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.


Bid opening shall be on **March 4, 2020 at 2:00 PM** at the Regional Headquarters Conference Room, Camp Efigenio C Navarro, Calapan City, Oriental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Post Qualification: The bidder with the Lowest Calculated Bid must submit a sample of the item within five (5) days from the opening/submission of bids for post qualification test and evaluation.

The PRO MIMAROPA Bids and Awards Committee reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
